They are continuing to work with Motorola and the ComNet System in migrating to the new spectrum. There was discussion on the ICI System Big Loop microwave connectivity and how it has transitioned into the primary connectivity for five of the eight active member cells with the decommissioning of pre-existing member owned hops and T-1 lease lines.
