South Bay/INSB, ComNet Expansion, Montebello Migration/Expansion, PasaGlen Merger are each proceeding as scheduled and within budget. There have been delays with the State and FEMA processing of EHP Reports and Sole Source Requests, some of which were filed as early as April.
