- Director Edey introduced and welcomed the new JPA Governance Board member representing City of Pasadena, Fire Chief Bertral Washington.

a. Reports Regarding Changes in Project Status from Previous Month

b. Report from Technical Committee

Chair Ron Derderian reported the following topics discussed during their November Technical Committee meeting: they are currently working on Ethernet site links; the quarterly patch process went well; there was a UPS failure but was resolved immediately by powering it down and bypassed completely; INSB added a new site and now have 6 sites in their cell; Baldwin Park has joined ICI; they are working on adding some addendum on ICI JPA Resolution 17-1 on Dues and Technical Compliance; training opportunities from Motorola to be made available to members and affiliate agencies.

- Director Edey informed the panel that for the next fiscal year, he will be working on identifying class sources and available funds for ICI sponsored training for the technical staff. He expressed the difficulty in finding specialized training classes that are necessary and specific for the ICI System that will ensure consistency and competency. He stated that he will work with Motorola representatives on this project and will present to the board their recommendations for approval.
- c. Report on Grant Funding and Status of Grant Funded Projects

As reported in previous meeting about the significant delay to Montebello 2015 SHSGP grant and other affected open grant projects, Director Edey informed the members that he had been requested generate several documents and provide detailed information pertaining to the projects. He was pleased to state that after fulfilling their requests, ICI finally got the sole source approval for Montebello and the project is now underway, as well as the Monterey Park Garvey site. He stated that now those requirements were completed, ICI is proceeding with newer grants that have not yet been initiated which are to upgrade all 9 Big Loops microwave hops, upgrading of Pomona console connectivity, and the expansion of Com-Net.

d. Report on Strategic Planning Session 2017-2018 – Staff Recommended Deferral

Director Edey recommended to the board members to defer the Annual Strategic Planning Session until March 2018 when all final projects are well underway. He explained that due to delays on current undertakings, there wouldn't be any changes or updates to be presented during the assembly if to be held in January as opposed to later date when new developments can be declared. He also announced that the City of Pomona volunteered to host the event.

- The panel agreed and had suggested that there should be a brainstorming session between all board members for input and recommendations that they could incorporate in the presentation.
