3. **REPORTS - INFORMATION**

- a. Report from Technical Committee & Member Cell Updates Mr. Arnold reviewed the minutes from the last Technical Committee
- b. Report from System Administrator on Law Enforcement Encryption Mr. Arnold advised that the majority of law enforcement agencies were now operating their primary dispatch talk groups in encrypted mode
- c. Report on Washington DC Delegation Meetings Attachment Mr. Edey reported on the ICI Washington DC Delegation September 12-14 attended by Chief Ellis (Chair), Chief Wenrick (Board Member), and Commander Davis-Moore (Vice Chair). and himself. The itinerary was shared and the 9 meetings detailed. The focus of discussion was funding for system upgrades.
- d. Report on Status of Grant Projects & Federal Funding Requests Mr. Edey reported that all grant projects were moving forward and are on schedule. The 2022 UASI for \$1 million TDMA Migration of the Pomona Cell is underway and Sole Source was approved. The Cops Technology Award of \$2.5 million has been accepted and the process initiated.

e. Report on Status of Network Migration to TDMA P-25 Phase II

Mr. Edey advised that the network presently has funding to proceed with migration of 9 of the system's 12 cells, several of which have been completed. There is a funding shortfall for Montebello's congressionally funded effort and we are seeking additional funds for that project. The migration funding for Santa Monica will be pursued in the 2024 UASI. The Glendale, Pasadena, and INSB migration remain to be funded. The COPS Grant is funding the \$2.5 million migration of Beverly Hills, Culver City, and ComNet.

f. Report on LACPCA Presentation October 25, 2023

Mr. Edey advised that the LACPCA has invited both LA-RICS and ICI to speak before their membership at their Temecula Conference to update the Police Chiefs of the status of each system and plans for interoperability. Mr. Edey and Mr. Arnold will be attending.
