b. Report of Staff re: Posting of Agenda. The Agenda for the February 6, 2014 Governance Board Meeting was posted on February 3, 2014, on the ICIS Web Site and the Bulletin Board outside Glendale City Hall.

2. ORAL COMMUNICATIONS

Executive Director reported that Chief Keetle has announced retirement. This will be his last ICIS meeting as he retires February 20.

Chair Goldman thanked Chief Keetle for his years of service to ICIS and his willingness to make decisions for the good of the whole. The Board and Staff thanked Pomona for being the first to migrate to P-25 and move ICIS forward.

3. REPORTS – INFORMATION

a. Reports Regarding Changes in Project Status from Previous Month

Pomona – No report

Montebello – No report

Glendale – The first hop in the microwave replacement of the Civic Center to Mt. Thom is scheduled to be completed in March. Repairs to the temperature issues need to be addressed before hot weather. Programming over to P-25 is proceeding. Glendale has given the go ahead to Motorola for the downtown repeater site for additional coverage. Next week there will be testing of the other six sites. Cut over to P-25 is still expected in the second quarter.

Culver City – No report

Burbank – Burbank is mid-cycle with the P-25 cut over - step 4 in the process. They are working on a 40 gig link between master site and Burbank.

Pasadena – There were many New Years Eve events and activities in Pasadena and all of their radio communication worked perfectly.

b. Report from Technical Committee

Steve Hronek reported that Joe Wilke has extended his leave as Secretary of the Technical Committee and Phil Areago of Beverly Hills has been appointed as Secretary. Steve reminded the Board to allocate the cost of the 7.14 upgrade in their city budgets. The jump from version 7.9 to 7.14 is a two step process, but as 7.14 is now out, the Technical Committee has requested that this upgrade be done in one step. Motorola has not yet responded.

The Technical Committee presented three motions:

-an affiliate agreement with San Gabriel PD, specifically with South Pasadena, but with all of Area C as well. No technical impediments or loading issues.

-an affiliate agreement with Monrovia PD. No technical impediments or loading issues.

-an affiliate agreement with Cal Sate LA PD. This request came through Monterey Park. The technical committee did not find loading issues, but would like the operations committee to also look at the request. Cal State LA PD has four APX7000 radios.

ICIS has approached the chief technician of UCLA system to see if they have interest in joining, especially considering proximity to Culver City. The UCs are working on new 800 trunk system of their own. There was no interest at this time, as UCLA intended to remain with an 800 MhZ system.

c. Report from Legislative Committee

The Washington DC trip has been planned for April 7 - 9. The Legislative Committee is also considering a one day State trip in May. There was direction to avoid the annual Legislative Day if a trip was to be planned.

d. Report from Operations Committee

Nothing to report but will agendize the Technical Committee's motions.

e. Report Regarding LA RICS

\$150 M in grant funds remains jeopardized because they have not begun to build out. They are scrambling for a funding plan but there are many gaps. The funding plan process is very much underway.

f. Report Regarding San Gabriel Valley JPA

Glendora Police Chief Staab introduced himself to the committee. Glendora is proceeding with Motorola at a slightly slower pace but the JPA will be signed on by early March and be fully functional in April. Glendora officers had complained about communications issues for a long time so everyone is excited about the change to ICIS. Thanked Pasadena for their assistance during the fire. Executive Director and Lucy Varpetian are drafting resolutions to formalize new members.

g. Report Regarding Budget Status Mid-Year 2013-2014

The 12-13 budget is on target for the first 6 months of fiscal year. El Monte's subscription of their Narcotics unit is added revenue to the budget. Microwave repairs will hopefully not be an issue for the budget again since it is being replaced with a new one this year. Each existing charter member should budget \$43,000 for the 2014-2015 fiscal year and \$46,000 for 2015-2016. All other members are \$46,000 as of this past fy.

h. Report Regarding Scheduled Washington, DC, Delegation Trip April 7 – 9: Agency and committee meetings on energy and homeland security. Board representatives from Glendale, Burbank, and Beverly Hills will be attending. Councilmember Laura Friedman (Glendale) and a councilmember or the mayor will be attending from Beverly Hills. The San Gabriel Valley JPA will try to send a representative.

The Board will table the appointment of the Technical Committee Chair until the next meeting so the Board may speak with their respective committee members. Steve Page will continue to serve as Vice Chair.
