b. Report from Technical Committee

Director Edey stated that there was no action item from the last Technical Committee meeting. He said that one item was deferred to the next meeting, which is a recommendation by the Committee to the board to consider contracting the City of Burbank to rent fiber connectivity between Glendale prime site and redundant prime site in Santa Monica.

c. Status of Operations Committee

The Operations Committee will hold their next meeting on October 13, 2016.

d. Status of Legislative Committee

The Director informed the panel that the Legislative Committee has not met in a while. He imparted that they are still seeking a volunteer from board members to Chair the group, but unsuccessful so far. Burbank advised they will have a potential candidate in the near future.

e. Status of P-25 Migration Project

Director Edey reported that the last two pieces of P-25 migration are the cities of Montebello and Culver City. He stated that Culver City already has their infrastructure, while Montebello is still waiting for final funding from the SHSGP Grants. Director Edey was optimistic that ICI System's move to P-25 is very close to completion, which they expect to be by end of June 2017.

f. Grant Update Report

Director Edey enthusiastically announced to the board that because of the great effort and support from the Police Chiefs Association and Fire Chiefs Association, ICI System was awarded the entire funding they requested in the 2016 SHSGP Grant application. He expressed that, thanks to the LA Mayor's office and Judge Bonner's very supportive recommendation to UASI, as well as Police Chiefs' and Fire Chiefs' support through SHSGP Grant, the ICI System is fully funded and will be built out and optimized throughout the County within a 2-3 years window.

- The board members conveyed their appreciation to Director Edey for all his efforts and hard work to make this project come into fruition.
